Planning and Community Development Building Rehabilitation Grant Program Application

(Revised February 1, 2023)

The purpose of the City of Eden Building Rehabilitation Grant program is to provide assistance and economic incentives to business owners to renovate and improve their properties. This program aims to increase economic activity, preserve the historic character of each property, and encourage the preservation of Eden's unique architectural assets. Applicants are eligible for up to 33.3% of the actual improvement costs – up to a maximum amount of \$5,000. Projects must meet all eligibility requirements, and complete the items listed in this application, to be considered to receive funding.

V. Funding and Eligibility

Under this grant program the applicant may request up to 33.3% of total project costs, up to a maximum amount of \$5,000.

- Work done by owner or applicant will not be funded for labor.
- Applications will be evaluated by the City of Eden Planning and Community Development staff. Scope and amount of grant funding will be determined on a case-by-case basis.
- The City of Eden reserves the right to reject any and all applications that do not meet the standard criteria.
- Property owners or tenants may apply, however, if the application is completed by a tenant, the owner of the property must sign the application as well.

- Properties are eligible to receive funding no more than once every two years.
- Applicants must submit receipts of work completed before funding will be received.

VI. Examples of Eligible Expenses

- Fire sprinkler system installation or upgrade including any needed water service improvements to accommodate a food or beverage service business in accordance with code requirements
- Restoration of historic interior architectural features including ceilings, light fixtures, floors, and architectural detailing
- Heating, ventilation, air conditioning, and drainage improvements
- Plumbing improvements
- Interior construction to rehabilitate a building to accommodate a new business or service
- Significant exterior repair including replacement of doors, windows or building reconstruction.
- Masonry repair and/or restoration
- Signage adhering to overall business aesthetic or historical architecture.

VII. Examples of Ineligible Expenses

- Building or land acquisition
- Design services, including architectural and/or interior design
- Emergency or safety related demolition expenses
- Flood, fire, or water damage repairs
- Furnishings, equipment, or personal property not in relation to permanent building structure
- Legal or permit fees
- Maintenance work (i.e., general repairs to maintain existing conditions)
- Landscaping
- Parking lot resurfacing
- Pest extermination
- Work proposed on property with an active code compliance citation
- Work begun prior to application submittal and approval
- Work begun prior to obtaining necessary permits.
